#### SOCCER TRAINING LIABILITY WAIVER AND RELEASE OF CLAIMS

THIS AGREEMENT is entered into by and between FC Extra Las Vegas LLC, its directors, officers, employees, agents, volunteers, independent contractors, and affiliates (collectively, the "Company"), and the undersigned participant (hereinafter referred to as the "Participant"), effective as of the date signed below. This waiver and release applies to any activities, events, and training programs organized by the Company, including those conducted on or off the field, and in connection with the Participant's participation in these activities.

# 1. Assumption of Risk

The Participant understands and acknowledges that participation in soccer training activities, including but not limited to practices, drills, games, physical conditioning, travel to and from events, and other associated activities (collectively, "Soccer Activities"), involves inherent risks. These risks include but are not limited to, physical injury, emotional or mental stress, or even death. These risks may arise from participation in activities both **on and off** the playing field, including during the use of soccer equipment, or while traveling to or from such events.

The Participant voluntarily assumes all risks and accepts full responsibility for any harm, injury, or damage that may occur during or after participating in Soccer Activities.

#### 2. Release of Liability

In consideration of being permitted to participate in Soccer Activities, the Participant hereby **releases**, **discharges**, **and holds harmless** the Company, its directors, officers, employees, agents, volunteers, independent contractors, affiliates, and any other persons or entities associated with the Company (collectively, the "Releasees"), from any and all claims, demands, actions, or causes of action for any injuries, damages, or losses, including but not limited to, personal injury, property damage, mental or emotional distress, illness, or death, that may result from the Participant's participation in Soccer Activities, whether such injuries occur on or off the field, whether caused by the negligence or intentional misconduct of the Company or otherwise.

The Participant acknowledges that this waiver and release of liability extends to all activities involving soccer training and related events, including those held on or near the training field, parking areas, spectator areas, and other premises associated with the Company's operations.

# 3. No Liability for Loss of Personal Property

The Participant understands and agrees that the Company is not responsible for any **loss**, **theft**, **or damage** to personal property, including but not limited to clothing, bags, equipment, valuables, or personal items, either on or off the playing field or while attending any soccer training sessions or events. The Company strongly encourages all participants to secure their personal items prior to engaging in Soccer Activities.

# 4. No Liability for Mental or Emotional Injury

The Participant acknowledges that participation in Soccer Activities may have both physical and emotional aspects. The Company is **not responsible for** any **mental**, **emotional**, **or psychological injuries**, including stress, anxiety, or other emotional harm that may arise from participation in the activities, social interactions, competition, or any other aspect of training.

## 5. No Guarantee of Athletic Achievement or Professional Career

The Participant understands that participation in Soccer Activities does not guarantee or imply any level of athletic achievement, success, or progression toward becoming a professional athlete. The Company **does not warrant** or guarantee that the Participant will develop sufficient skills or abilities to attain a professional level of play, nor does it make any promises or representations concerning future athletic opportunities or contracts. Success in soccer or professional athletics depends on many factors, including talent, work ethic, and external circumstances beyond the Company's control.

#### 6. Medical Treatment Authorization

In the event of injury, illness, or emergency during Soccer Activities, the Participant **authorizes the Company** to obtain medical treatment or emergency services for the Participant as deemed necessary. The Participant understands that the Company will not be responsible for any medical costs incurred, and that all expenses related to medical care will be borne solely by the Participant or the Participant's insurance.

### 7. Indemnification

The Participant agrees to **indemnify and hold harmless** the Company and the Releasees from any and all claims, damages, liabilities, losses, expenses, or legal fees arising from any injury, damage, or claim resulting from the Participant's participation in Soccer Activities, including the actions of any third parties.

#### 8. Governing Law and Jurisdiction

This waiver and release shall be governed by and construed in accordance with the laws of the State of Nevada, without regard to its conflict of laws principles. Any dispute arising out of this agreement shall be resolved exclusively in the courts located in **Clark County**, **Nevada**.

# 9. Severability

If any provision of this waiver and release is found to be unenforceable, invalid, or illegal by a court of competent jurisdiction, the remaining provisions shall remain in full force and effect.

#### 10. Consent for Use of Likeness

The Participant grants the Company permission to use their name, image, likeness, voice, or any recordings or photographs taken during Soccer Activities for marketing, promotional, or advertising purposes, without compensation or further approval.

This liability waiver is part of FC Extra's Terms and Conditions and is agreed upon when filling out FC Extra's official enrollment and trial session forms.

## **Additional Notes:**

1. **Age Requirement**: If the Participant is under 18, a parent or legal guardian must sign and assume responsibility for the waiver.

- 2. **Scope of Waiver**: This waiver explicitly covers both physical and mental injuries, and losses of personal property, and clarifies that participation in the training program does not guarantee professional advancement.
- 3. **Jurisdiction**: The waiver references Nevada law and Clark County courts to ensure any legal disputes are resolved in your business's jurisdiction.
- 4. **Professional Athlete Disclaimer**: A clear statement has been included to ensure participants understand that the training does not guarantee professional success.
